Women play **Wednesday, 2/11**. **Men** play **Thursday, 2/12**. Play is doubles. Partners assigned by tournament directors. (Pairings are based on your playing level.) There is space for 96 participants each day. There are 4 two hour sessions (8:00 a.m., 10:00a.m, noon, and 2:00 p.m.). Play will be round robin. You'll be assigned to one of the 2 hour sessions based on your level. Refreshments and snacks will be provided by the Tennis Club.

Mixed doubles play **Sunday, 2/15**. **Mixed doubles requires you to get you own partner.** We would like this to be competitive so it is important that you play with someone of similar ability. For example, if one member of the doubles team is a 4.0 and one member is 3.5, they would play in the 7.5 level. Two 4.0's would play in the 8.0 level; a 3.5 and 3.0 would play at the 6.5 level. You cannot play with someone that is 2 levels below the highest ranked player on the team (i.e., 4.0 player and 3.0 player (or beginner).
