There is space for 72 participants each day. There are three 1 1/2 hour sessions (12:00 pm., 1:30 pm, and 3:00 p.m.). Play will be round robin. You'll be assigned to one of the 1 1/2 hour sessions based on your level. Refreshments, snacks and balls will be provided by the Tennis Club.

**Mixed doubles play Sunday, 2/19.** Play will be at 9:30 am, 11:00 am, LUNCH at 12:30 pm. Play again at 2:00 pm and 3:30 pm, if necessary. We would like this to be competitive so it is important that you play with someone of similar ability. For example, if one member of the doubles team is a 4.0 and one member is 3.5, they would play in the 7.5 level. Two 4.0's would play in the 8.0 level; a 3.5 and 3.0 would play at the 6.5 level. You cannot play with someone who is 2 levels below the highest ranked player on the team (i.e., 4.0 players and 3.0 player (or beginner).
